ACKNOWLEDGEMENT, WAIVER, AND ASSUMPTION OF RISK

We acknowledge that we have read and are aware of the risk of the spread of the Covid-19 virus by participating in Bellair Barracudas swimming practices held at Bellair Parks & Recreation pools at this time. We acknowledge that we have read these policies on handling this matter, and have been referred to the Center for Disease Control website to understand this pandemic, its risks, and how to mitigate community spread of this illness.

Parent/guardian initial:

Bellair Barracudas disclose that:

There are certain risks of practicing swimming in a group at this time. The virus can spread before another person shows signs of the virus or is symptomatic. The CDC advises that everyone should:

- Continue to practice personal protective measures.
- Continue to put a household plan into action.
- Consider staying at home and avoiding gatherings or other situations of potential exposures, including travel, if you are an individual at increased risk of severe illness.
 - Stay at home if you might infect an individual at increased risk of severe illness. Bellair Barracudas also
- requires that anyone who is sick, has symptoms of COVID-19 or who has reason to believe they have had contact with anyone with COVID-19 should not participate in any manner or attend a practice.

Parent/guardian initial:

You understand and acknowledge that COVID-19 is caused by a new virus. There is much to learn about its transmissibility, severity, and other features of the disease. The virus is thought to spread mainly from person-to-person. It is thought to spread between people who are in close contact with one another and through respiratory droplets produced when an infected person coughs or sneezes. These droplets can land in the mouths or noses of people who are nearby or possibly be inhaled into the lungs.

Parent/guardian initial:

You acknowledge that there are risks and dangers with regard to COVID-19 and being in a public setting, including a swim practice. These risks and dangers may be caused by the negligence of participants, other swimmers, accidents, breaches of protocols, the forces of nature or other causes, and may be from foreseeable or unforeseeable causes. Parent/guardian initial:

If your non-adult swimmer, participates in a Bellair Barracudas practice, you (and he or she) assume all risks and dangers and all responsibility for any losses, damages, or injuries, whether caused in whole in part by the negligence or other conduct of the owners, agents, officers, employees of Bellair Barracudas, Bellair Parks & Recreation, or by any other person.

Parent/guardian initial:

SWIMMER(S) POLICIES AND PROCEDURES

PREPARING TO SWIM - Protect against infections:

- Use the restroom and wash your hands with a disinfectant soap and water before coming to practice (for 20 seconds or longer) and use a hand sanitizer once on site before getting into the pool.
- Do not share equipment.
- Bring a full water bottle to avoid touching a tap or water fountain handle.
- If you need to sneeze or cough, do so into a tissue or upper sleeve/arm area. If you don't feel well you must leave immediately. If a coach suspects you are sick you will be required to leave.
- Arrive no sooner than 5 minutes before your scheduled practice time.
- Avoid touching gates, fences, benches, etc.
- Do not attend practice if you, or a member of your household does not feel well.
- Stretch and warm up before arriving as swimmers will go straight to the pool.

WHEN SWIMMING

- Follow directions for spacing and stay at least six feet apart from others.
- Do not make physical contact with others, such as shaking hands or giving a high five.
- Avoid touching your face.
- Avoid sharing food, drinks, or towels.
- Maintain appropriate social distancing from other athletes when taking a break.
 - Wear your suit to and from practice.

AFTER SWIMMING

- Leave the facility as soon as practice ends and you have gathered your belongings; you must be out of the pool area within five minutes of the end of practice.
- Wash your hands thoroughly or use a hand sanitizer after leaving the pool.
- Do not use the locker room or changing area.
- Shower at home, wear your suit to and from practice
- No extra-curricular or social activity should take place.
- No congregation after swimming.

Practices are closed only to swimmers and coaches. No parents/guardians will be allowed in the pool area. Parents/guardians will remain in vehicle upon dropping and/or picking up. Parent/guardian initial:
